## ELI's approach:

- **Provides Thought Leadership:** by researching and analyzing cutting-edge legal issues and implementation challenges and the state of laws and regulations, including their scientific, economic, and policy dimensions and presenting this information in ELI books, research reports, and educational seminars.

ELI was originally formed as a publisher to present the best legal and policy analyses of environmental and natural resource issues, and continues to play this role, providing a forum through which to highlight innovative environmental law and policy solutions by cutting-edge authors. Publications include the award-winning *Environmental Law Reporter (ELR)*, the most-cited environmental law review in the nation ("The best legal resource on earth.<sup>TM</sup>"), and *The Environmental Forum*, the leading policy magazine for professionals in environmental law, policy, and management.

- **Catalyzes Effective Law Formation:** by developing draft and model legal and implementation instruments and disseminating them to policymakers.

- **Offers Change-Oriented Training, Education, and Capacity-Building:** by providing policymakers, enforcement and compliance personnel, business leaders, communities, prosecutors, judges, and others with the information they need to address environmental problems and improve environmental governance. For example, in partnership with local groups, ELI has trained thousands of judges in dozens of countries.
- **Convenes Stakeholders and Crosses Policy Divides to Build Consensus:** by bringing together key players in the environmental law, management and policy communities to engage in dialogue and transcend political impasse through ELI's reputation as an "honest broker" that facilitates constructive solutions.
- **Drives Solutions:** by analyzing and showcasing successful laws, policies, and governance solutions to promote best practices and standardization across political borders in countries around the world, at the state and federal levels in the United States, and through reviewing the important contributions of private companies.
